LEADERSHIP

Recap: Elected Lay Leaders Meeting Sunday, 1/28

As was shared in the January Spire, Church Council, guided by Federated's purpose, has strategically examined the Church's infrastructure needs and recommends to the congregation the sale of the Family Life Center (FLC) property, offering the Community Life Collaborative (CLC) the right of first offer to purchase the FLC property at 90% of fair market value. However, if the CLC is not the purchaser, the new owner will abide by the conditions in the current CLC management agreement through its expiry date (of March 31, 2025).

The objective of the meeting, attended by 41 of the 54 elected lay leaders, was for the Church Council to share more about this strategic recommendation, and most importantly, to listen to their thoughtful questions and comments. Dawn Herdman, Membership and Nominating Committee and Evaluation Team member, opened with prayer at 11:20am.

Greeting

Adam Graves, Moderator of Church Council, thanked those in attendance and shared the guidelines that each person is welcome to speak for 2 minutes, and may not speak again until everyone else has had an opportunity to speak.

Adam shared that Church Council views the CLC and FLC as two separate matters and strongly commends and affirms the work the CLC is doing as an organization and strategic partner, but as the owner of the FLC property, Federated Church is responsible for its preservation. Four dimensions were considered by the Church Council when making this critical decision: Strategic, Financial, Operational and Cultural.

STRATEGIC DIMENSION


Is owning and maintaining the FLC property strategic to Federated Church's vision of its future? Adam addressed the questions and comments related to "Why Now?" and "Can the process be paused?" by reviewing the *Principles and Milestones* given to the CLC in August:

Principles and milestones: Fall CLC / FLC Evaluation

Principles:

- The purpose of the Evaluation Process is to provide the Church and CLC a mutual checkpoint of the collaboration
- Council Members must stay true to our shared Covenant
- Transparency and clarity along the journey

Milestones:



Action for September 5th Council meeting: Come prepared to decide on pre-submitted nominees for 3-person Evaluation joint Church + CLC task force.

- In October, an Evaluation Team of three individuals from Federated Church and three individuals from CLC determined the partnership between the organizations is functioning as intended and all agreed not to exercise the (early) "Exit Option." This means the Management Agreement will remain intact through the 3/31/2025.
- The Management Agreement stipulates formal notice must be provided to the CLC regarding an extension of the Agreement or creation of a new Agreement (if the Exit Option is not exercised). 3/31/2024 is when formal notification of changes will be provided to the CLC.
- A figure of ~\$4.3 million was provided as the total property value of the Family Life Center property and it was noted that, similar to owning a car that has depreciated over time, the FLC's value has depreciated to ~\$2.3 million. The current responsibility of the congregation of the Federated Church is to make the best possible decision with the information available.
- The proceeds from the sale of the FLC would be used to
 - Design and construct a Memorial Garden at 76 Bell as envisioned by a thoughtful task force of individuals dedicated to preservation of those memorialized
 - > Increase Deferred Major Maintenance Designated Fund
 - > Support Federated's missions by fully investing in our Visionary Action Plan (VAP)
- Many attempts over the past couple of decades have failed to achieve what was initially envisioned for FLC property.

FINANCIAL DIMENSION

Is money invested in the maintenance of the FLC property the best use of Federated Church funds?

Brady Hively, Chair of the Finance & Properties Committee, addressed the anticipated 1-4 year major maintenance items. In the following chart, "Estimates in 2023" column were provided by professionals who suggested an average of 6% increase per year, as reflected in the "2024" column.

Bainbridge Property Family Life Center	Estimates in 2023	2024
HVAC	\$273,080	\$342,465
Paving	\$187,000	\$196,350
Roof/Siding	\$165,707	\$182,277
Misc.	\$35,995	\$35,995
Total	\$661,782	\$759,111

- In order of priority the FLC property's major maintenance items are: HVAC, Roof and Parking Lot.
- In the past those interested in purchasing the property were not interested in building and therefore anticipated repairs were not a factor "discounting" the selling price.
- \$165,000 is in designated funds for the maintenance of the FLC property.
- CLC pays the day-to-day expenses and major maintenance items are to be paid by Federated Church.
- There was a \$1 fee paid to the Federated Church for each of the first two years of use, year three is \$20K and year four is \$30K; these fees go into Federated's Operating Budget. The Management Agreement ends March 31, 2025.
- The overall financial position of Federated Church has not substantially changed and details to follow in the 2023 Annual Financial Report.
- Exploration in the past of selling 102 Bell proved to be prohibitive as 102 Bell and 76 Bell share the driveway and electricity.

OPERATIONAL DIMENSION

Is the FLC property essential to the Federated Church's physical infrastructure?

- The overall financial position of Federated Church has not substantially changed and details to follow in the 2023 Annual Financial Report.
- Exploration in the past of selling 102 Bell proved to be prohibitive as 102 Bell and 76 Bell share the driveway and electricity.
- Church Council and several others shared the perspective that many, if not all, of the CLC's activities could be managed from or held at the 76 Bell location or elsewhere.
- Many Church Councils, including as recent as 2019, have addressed the question if Federated can
 financially afford its physical space. Using the appreciative inquiry approach and extensive research,
 past and current Church Councils have arrived at same conclusion: that Federated Church cannot be
 financially sustainable if funds are used to maintain the FLC property.
- In 2019 the concept of forming a partnership with the CLC was presented and overwhelming approved by the Congregation at its meeting in 2020, and Church Council hopes the CLC will continue its impactful work by operating out of 76 Bell Street, so that Federated Church can continue to energetically support the continued implementation of the Visionary Action Plan (VAP) by expanding its programs, ministries and missions.
- The CLC has not had an opportunity to investigate the possibility of purchasing the FLC property, but is aware that the property is zoned for residential use, and that the CLC is able to operate under the conditional use provision awarded to the Federated Church.

CULTURAL DIMENSION

Is the FLC property seen as essential to the cultural fabric of the Federated Church?

- A board member of CLC shared the FLC property provided 500 touchpoints to the community and in the future the CLC envisions solar array and electric charging stations, and questions if this community building could take place at a "steepled" building.
- While respecting and deeply appreciating the strong emotional and impassionate connection to the FLC Memorial Gardens, it is enjoyed by relatively few people and on an intermittent basis.
- Memorial stones at 76 Bell would provide an opportunity to reflect upon these 'saints' every time friends and members of Federated Church come to worship.
- The Real Estate Task force (2019) investigated the possibility of retaining just the Memorial Gardens
 and given its location in the center of the property determined that a special access easement to the
 gardens was impractical.
- A land study of the FLC grounds was forwarded to some members of the CLC and Church Council showing that drainage at the FLC was not adequate to support in-ground gardens, and that building raised beds could be cost prohibitive.

In Conclusion

The decision to sell the FLC property is one that will be made by the members of the Federated Church and each member has an equal vote. The question of Absentee and/or Proxy Voting will be determined at the February Church Council meeting.

Great News from our Creation Care and Justice Corner!


